


**Expired -** Products that have expired from ZDHC MRSL v2.0 or ZDHC MRSL v3.0 Conformance.

#### **ZDHC MRSL v3.0**

Document review of SDS for information relevant to ZDHC MRSL and testing of the formulation which includes screening and analytical testing or only analytical testing.



Onsite assessment of management systems plus evidence that Level 1 principles of analytical evaluation for ZDHC MRSL conformance are fulfilled.







### **ZDHC MRSL v2.0**

Passed a third-party review of documentation or an analytical test report where the data meet the QA and QC requirements in the MRSL Conformance Guidance to be accepted as evidence of conformance.

All requirements for Level 1 passed and passed a review of the product stewardship practices of the chemical supplier by the third-party certifier.

All requirements for Level 2 passed and passed a site visit to the chemical formulator to evaluate their product stewardship first-hand.
